## TERMS & CONDITIONS

1. Applications for membership are subject to all rules and regulations of the Glastonbury Hills Country Club, Incorporated (hereafter GHCC, Inc.), which may accept or reject an application at its sole discretion.
2. Membership is subject to the rules and regulations of GHCC, Inc., a copy of which has been provided to Applicant, and the receipt of which is hereby acknowledged.
3. Applicant hereby acknowledges that all amounts paid to GHCC, Inc. for deposits, fees, initiation fees, and dues, will not be held in “trust” or “escrow”. The Applicant also acknowledges no deposits, fees, initiation fees, or dues shall be refunded at any time during their membership or at termination of their membership.
4. The Applicant agrees to remain a member for a period of one calendar year, from January 1<sup>st</sup> to December 31<sup>st</sup> of any year. All memberships expire on December 31<sup>st</sup>, and are subject to renewal for one year. GHCC, Inc. may accept or reject any renewal contract application at its sole discretion.
5. The Applicant acknowledges having read the rules and regulations of GHCC, Inc. and the current schedule of fees and monthly and yearly dues. GHCC, Inc. reserves the right to change the rules and regulations, fees, charges, and membership privileges without prior notice. The Applicant agrees to abide by all rules, regulations, and policies promulgated by GHCC, Inc. management, and to exercise due care in the protection and maintenance of GHCC, Inc. property, grounds and facilities.
6. The Applicant agrees to be responsible for payment of any and all charges incurred by Applicant, Applicant’s family, and Applicant’s guests related to the use of GHCC, Inc. facilities. GHCC, Inc., at its option, may charge interest on past due accounts at a rate designated by GHCC, Inc. from time to time, which may be up to the highest rate permitted by law. It will be necessary for GHCC, Inc. to obtain a credit report, which GHCC, Inc. reserves the right to approve or disapprove at its sole discretion, and Applicant’s dues and fees will be billed through a designated GHCC, Inc. charge plan. Applicant must establish and maintain an adequate credit line at all times. If GHCC, Inc. determines the Applicant’s credit line and/or credit report is unsatisfactory, GHCC, Inc. may require a deposit, the amount of which will be determined by GHCC, Inc.

The Applicant agrees to be responsible for the behavior of, and any damages caused by, the Applicant, the Applicant’s family, and the Applicant’s guests related to the use of GHCC, Inc. facilities. Applicant understands that GHCC, Inc., at the sole discretion of the management, may restrict the use of GHCC, Inc. by guests. Applicant understands that membership may be suspended or revoked if the GHCC, Inc. rules, regulations, or policies are violated by the Applicant, Applicant’s family or Applicant’s guests.

9. Membership does not confer any proprietary interest in the facilities or assets of GHCC, Inc. Applicant will not acquire any non-terminable rights to use the GHCC, Inc. facilities. Membership is personal to the Applicant, and as expressly provided in the rules and regulations, is not transferable, "saleable" or refundable, and may not be pledged or used as collateral.
10. For so long as this agreement remains in effect, Applicant will enjoy playing privileges as defined in the rules and regulations of GHCC, Inc. All playing privileges will be subject to payment of any golf fees, dues and other fee charges, and will be subject to availability.
11. Applicant hereby agrees that GHCC, Inc. and its employees or agents shall not be liable for any loss or damages arising out of Applicant's use of GHCC, Inc. facilities.
12. If, for any reason, the application is not approved by GHCC, Inc., all funds paid hereunder shall be refunded to Applicant, and the application shall be deemed void. A previous violation of GHCC, Inc. rules and regulations by the Applicant may constitute grounds for a denial of membership. Applicant waives any and all claims that may arise or accrue to Applicant against GHCC, Inc. because of denial of membership. Applicant acknowledges that the foregoing constitutes the entire understanding between Applicant and GHCC, Inc., and that there are no other written or oral understandings, promises or agreements between them on which Applicant has relied in making this application.
